Vertical Banner / Fishtail Terms & Conditions

- 1.1 Fishtail must be securely fastened, hanged at least 6 feet from ground level measured from the bottom of the fishtail and maintained in good state during the period of the display.
- 1.2 License issued for the display of fishtail at protocol roads are subject to reservation by Council at any time if the sites are required for any important Government events / functions and license fee paid shall not be refunded.
- 1.3 All vertical banners/fishtails shall provide a white space of size 2 inches or 50mm across the bottom of the vertical banner for display of license number.
- 1.4 All vertical banners/fishtails shall be **displayed in running order** according to the folio number.
- 1.5 **Licence number and folio number** must be written on the fishtail for easy identification. Fishtail without licence number and folio number will be removed by Council.
- 1.6 The erection of posts at public place of road verges, road reserve, open space, etc for such purpose is prohibited.
- 1.7 Fishtail must be removed within **two (2) days** after the expiry of the licence.
- 1.8 Size of fishtail shall not exceed the approved size and content must be non-offensive in nature.
- 1.9 All tobacco and liquor advertisements are not allowed.
- 1.10 2 tiers advertisement on lamp post is not permitted.
- 1.11 Fishtail shall not be displayed on the post of traffic light and the 1st lamp post from the traffic light.
- 1.12 Fishtail shall not be displayed other than the approved site(s).
- 1.13 The number of fishtails displayed cannot exceed the approved quantities.
- 1.14 Security deposit will be forfeited for non-compliance with any of the above condition(s).
